##### Enrolment Fees

## APPLICATION & PROCESSING FEES FOR INTERNATIONAL STUDENTS

(Not applicable to Online - Open & Distance Learning (ODL) Mode)

### STAGE 1

(Payable upon acceptance of offer)

RM 3,350 (approx. USD 780)\* is payable when you have accepted the offer. This fee includes Visa Processing Fees by Education Malaysia Global Services (EMGS) and APU/APIIT Application & Processing Fees. This also entitles you to airport assistance and transfer to the University/accommodation upon first arrival in Malaysia. Please note that this Fee is non-refundable once the offer has been accepted.

### STAGE 2

(Payable upon Student Pass Visa Approval)

RM 1,500 (approx. USD 350)\* is payable once your Student Pass is approved. This fee includes the post-arrival processing fee, EMGS medical check-up in Malaysia, Medical Insurance for a year, i-Kad (International Student Card issued by Immigration Malaysia) charged to ALL International students in Malaysia, Electronic Visa Approval Letter (eVal), and the Student Pass Fees for one-year. The i-Kad issued by Immigration Malaysia will enable students to avoid having to carry their passports around for identification purposes and will be tied to their Student Pass Validity and will be re-issued at visa renewal. Please note that this Fee is non-refundable once the Student Pass Visa Approval Letter (VAL) has been issued by EMGS.

Please note that International Students are not allowed to change the course of study, once the visa has been applied. International Students are required to re-apply for a new Student Pass (Visa) should they decide to change the programme and is subject to Immigration approval.

**Events Resource Fees**

### Personal Bond

A Personal Bond of RM 1,000 (approx. USD 235)\* is payable, which will be refunded on completion of studies. The Personal Bond will not be refunded should any situation arise where the student is found to have either misused their visa or violated any regulations applicable to International Students in Malaysia. In the event where the University is required to intervene to assist students with Law Enforcement Agencies, deduction will be made from the personal bond to recover cost of assisting.



### \*APU-DMU Dual Degree Scheme

APU's partnership with De Montfort University (DMU), UK enables students to be awarded Dual Awards - separate degree certificates from each institution - and enhances not just teaching and learning experiences, but also career prospects.

Upon graduation, students will receive 2 Degree Certificates & Transcripts: 1 from APU, Malaysia and 1 from DMU, UK.

Additional Fee of GBP 425 per level is payable should you opt for the Dual Degree Award scheme with De Montfort University, UK. This is payable upon commencement of Study. Non-payment at Commencement will result in non-registration with De Montfort University for the Dual Awards. Payment can be made either in GBP Cash or USD/ RM equivalent (at the prevailing exchange rate available at the APU/ APIIT Cashier).
