TERMS AND CONDITIONS

- Prior to flying to college, the 1st year tuition fee must be paid (ie no tuition fee clearance, no immigration clearance).
- After the student has cleared payment, a clearance letter will be updated and forwarded to KLIA immigration.
- If the student fails the medical after arriving in Malaysia, the tuition fee paid will not be refunded.

DOCUMENTS REQUIRED FOR THE ISSUANCE OF AN OFFER LETTER AND THE APPROVAL OF A VISA

1. Passport all pages (must be colour scanned)
2. SSC/O-level/GCE/10th Standard (Certificate with transcript/mark sheet)
3. Photo (with plain white background) (45 mm [h] by 35 mm [w]), please click the link below to view the image

4. Only those aged 18 to 29 may eligible to apply for a diploma.

5. Applicant must present an updated resume and job experience if their study gap exceeds one year.
6. **The student must sign a health declaration form certifying that they are disease-free before the college submits the paperwork to the immigration department.**

7. For **ACCA Qualification** course [3C is required from 10th Standards including Mathematics and 2C from 12th Standards in any two subjects i.e. total credits required is 5C (10th +12th)].
8. **ACCA FIA** requires 5C from 10th standards including Mathematics.
9. **ACCA & ACCA FIA external exam fees are NOT included in the tuition fees.**
10. The results of the English proficiency test must be presented either before the main course begins or when the application is submitted to the immigration or admissions department.
